4 FIRST-AID MEASURES

INHALATION

Move the exposed person to fresh air at once. Keep the affected person warm and at rest. Get prompt medical attention.

INGESTION

Rinse mouth thoroughly. Provide rest, warmth and fresh air. DO NOT INDUCE VOMITING! NEVER MAKE AN UNCONSCIOUS PERSON VOMIT OR DRINK FLUIDS!

SKIN CONTACT

Remove affected person from source of contamination. Get medical attention if any discomfort continues.

EYE CONTACT

Remove victim immediately from source of exposure. Make sure to remove any contact lenses from the eyes before rinsing. Promptly wash eyes with plenty of water while lifting the eye lids. Continue to rinse for at least 15 minutes and get medical attention.

5 FIRE-FIGHTING MEASURES

EXTINGUISHING MEDIA

Fire can be extinguished using: Alcohol resistant foam. Carbon dioxide (CO2). Dry chemicals, sand, dolomite etc. Foam.

SPECIAL FIRE FIGHTING PROCEDURES

Move container from fire area if it can be done without risk.

UNUSUAL FIRE & EXPLOSION HAZARDS

If heated, volume and pressure increases strongly, resulting in explosion of container.

6 ACCIDENTAL RELEASE MEASURES

SPILL CLEAN UP METHODS

Wear necessary protective equipment. Extinguish all ignition sources. Avoid sparks, flames, heat and smoking. Ventilate.

7 HANDLING AND STORAGE

USAGE PRECAUTIONS

Keep away from heat, sparks and open flame. Avoid spilling, skin and eye contact. Ventilate well, avoid breathing vapours. Use approved respirator if air contamination is above accepted level.

RESPIRATORY EQUIPMENT
